{¶ 1} The Dayton Power and Light Company (DP&L) is a public utility, as defined in R.C. 4905.02, and, as such, is subject to the jurisdiction of this Commission.

{¶ 2} On June 24, 2009, the Commission issued an Opinion and Order adopting a stipulation approving DP&L's application to establish an electric security plan (ESP). *In re The Dayton Power and Light Co.*, Case No. 08-1093-EL-SSO, et al., Opinion and Order (June 24, 2009). The ESP provided for, among other things, the establishment of a fuel adjustment clause (FAC) mechanism, effective January 1, 2010, with annual audits of DP&L's fuel costs and fuel management practices. Thereafter, on September 4, 2013, the Commission authorized DP&L to establish a second ESP, which also contained a fuel rider. *In re The Dayton Power and Light Co.*, Case No. 12-426-EL-SSO, et al., Opinion and Order (Sept. 4, 2013).

{¶ 3} On March 19, 2014, in Case No. 14-117-EL-FAC, the Commission issued an Entry selecting Energy Ventures Analysis, Inc. (Auditor) to perform a management/performance and financial audit for the years 2013 and 2014. Thereafter, on October 2, 2015, in the present case, the Auditor filed the management/performance and financial audit for the period January 1, 2014, through December 31, 2014.

{¶ 4} On May 10, 2016, a stipulation and recommendation signed by all of the parties in this proceeding was submitted in this case.

{¶ 5} Accordingly, the attorney examiner finds that this matter should be set for hearing. The hearing in this matter will be scheduled for June 27, 2016, at 1:00 p.m., at
