On April 9, 2014, the Public Utilities Commission of Ohio approved a stipulation, in Case No. 13-1141-GE-RDR, in which Duke Energy Ohio, Inc., agreed to extend Rate TD-13, Sheet No. 121, through May 31, 2016. Pursuant to that Commission order, the attached, amended tariff sheet (both clean and red-lined versions) terminates Rate TD-13, effective June 1, 2016.

Rate TD-13 was an optional rate that applied only to residential customers. All participating customers have been notified of the impending rate change. They will be billed under Rate RS, Residential Service, beginning with the June 2016 billing.

#### RATE TD-13

## OPTIONAL TIME-OF-DAY RATE FOR RESIDENTIAL SERVICE WITH ADVANCED METERING (PILOT)

### THIS TARIFF IS HEREBY CANCELLED AND WITHDRAWN

#### **APPLICABILITY**

- Applicable to electric service for all domestic purposes in private residences and single occupancy apartments in the entire territory of the Company where distribution lines are adjacent to the premises to be served. This rate is available only as Company advanced meters with interval recording registers are installed on the customer's premises. The advanced meters must be commissioned, certified, and provide billable quality data. Eligible customers must receive generation service from Duke Energy Ohio, and they must have had a total annual electric bill of \$300 or more during the prior 12 months. This rate is not available to customers who participate in the Power Manager program nor is it available to customers on the Percentage of Income Payment Plan (PIPP) program.
- Where all dwelling units in a multi-occupancy building are served through one meter and the common use area is metered separately, the kilowatt-hour rate will be applied on a "per residence" or "per apartment" basis, however, the customer charge will be based on the number of installed meters.
- Where a portion of a residential service is used for purposes of a commercial or public character, the applicable general service rate is applicable to all service. However, if the wiring is so arranged that the service for residential purposes can be metered separately, this Rate will be applied to the residential service, if the service qualifies hereunder.
- Rate TD-13 is offered on a pilot basis. The Company reserves the right to modify this rate, subject to approval by the Commission, as information regarding customer participation, load response, costs, and other pertinent information becomes available. If the Company changes the base generation charges or structure of this rate, customers who have not completed their initial term of service may continue taking service under Rate TD-13 or switch to Rate RS (Residential Service) or any other rate for which the customer is eligible. Should there be a change to base generation charges or the structure of this rate, customers will be notified electronically (where available) or by mail.

For customers taking service under any or all of the provisions of this tariff schedule, this same schedule shall constitute the Company's Standard Service Offer.

A customer will be required to designate a single summer 3-hour time period and a single winter 3-hour time period. Those six (6) designated hours are applicable to weekdays only and constitute the summer and winter On Peak Periods respectively. All weekday hours not so designated, plus all day Saturday, Sunday, and holidays, plus all hours not included in the summer and winter periods constitute the Off Peak Period.

Holidays are New Year's Day, President's Day, Good Friday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veteran's Day, Thanksgiving Day and Christmas Day, or on the day nationally designated to be celebrated as such with the exception that if the foregoing holidays occur on a Sunday,

the following Monday is considered a holiday.

— Applicable charges for the On Peak and Off Peak Periods are provided in Riders RE, RC and ESSC.

#### **MINIMUM CHARGE**

The minimum charge shall be the Customer Charge as stated above.

#### **LATE PAYMENT CHARGE**

Payment of the total amount due must be received in the Company's office by the due date shown on the bill. When not so paid, an additional amount equal to one and one-half percent (1.5%) of the unpaid balance is due and payable.

#### **TERMS AND CONDITIONS**

- This rate is available upon application in accordance with the Company's Service Regulations.
- The initial term of service under this rate is twenty-four (24) months. After twelve (12) months, customers may at their discretion switch to another applicable rate. During the initial or any subsequent twenty-four (24) month term, should the customer apply for the Percentage of Income Payment Plan (PIPP) program, they will no longer be eligible for service under Rate TD-13.
- The supplying and billing for service and all conditions applying thereto are subject to the jurisdiction of the Public Utilities Commission of Ohio, and to Company's Service Regulations currently in effect, as filed with the Public Utilities Commission of Ohio.
