I object to a large, high pressure gas line being proposed for installation in highly developed residential areas, especially those near schools, universities, and places of worship, as is the case with all the currently proposed routes for the Central Corridor Pipeline. Common sense and concern for society require re-thinking of the proposed routes in terms of residential and community safety as well as environmental factors.

One may argue that there are hardly any places in a metropolitan area where placement of a line would not affect areas with existing high levels of development. Exactly the point. Such pipe lines should be routed away from metropolitan areas, not through them.

This was a previously "failing" school that is now winning academic awards, and has become a thriving neighborhood school with its own community supported educational garden. The school is diverse in racial and socioeconomic makeup, a safe place for many children who have harder lives at home.

As I understand it, the pipeline will pass within 100s of feet of the school, putting the school cleanly in a blast zone should one occur.

Please do not allow this pipeline to put the lives of 100s of children -- including my own -- at risk on a daily basis. And please do not put the growth of a unique school at risk.
