COMMENTS: We are writing to voice our concern regarding the 30" 700psi natural gas pipeline proposed by Duke Energy. One of the three routes proposed will pass not even 25 feet from the front of our home. We attended the informational meeting in Blue Ash, Ohio on June 15th, 2016. The maps of the three proposed pipeline routes were not labeled and were not arranged in any obvious sequence. No one at Duke gave us any information regarding the pipelines safety or necessity. We walked away feeling Duke's only reason for this meeting was to gather information from concerned residents. On June 28th, 2016 we attended a City of Reading Council Meeting and witnessed the Resolution #2016-45R Unanimous Passage, Expressing Opposition to Duke Energy's Central Corridor Pipeline Extension Project.

As residents of Reading and Hamilton County we oppose this project in its entirety. We challenge its necessity, safety, and negative impact on property values. Who in their right mind would want to live a few feet from a potential time bomb?
