I am writing in opposition to Duke Energy's Central Corridor Gas Pipeline Extension Project, docket number 16-0253-GA-BTX.

The planned proposed green and pink routes would be less than 1000 feet from my company's headquarters. The planned proposed orange route would be less than 1500 feet from my company's headquarters. As such, each of these planned proposed routes could potentially place myself, my husband and our employees at GRAVE RISK should this 30 inch 720 PSI gas transmission pipeline leak and/or worse yet, explode!
