My research is now complete, depending on which code I am being charged with, texting while driving as originally accused of or having a mapping application on my phone while the vehicle is in motion.


I am yet unable to hire legal counsel because they want to see the actually charge and case number. Nobody has been able to find my case using the current case number I was given.


