Duke Energy wants to run a massive, high-pressure natural gas pipeline directly through densely-populated neighborhoods, schools, hospitals, day care centers, and places of worship in the Cincinnati area. This is an unprecedented project and a massive safety hazard--an explosion could kill or injure thousands of residents within the pipeline's path--and yet Duke is undeterred and will effectively be allowed to regulate itself. 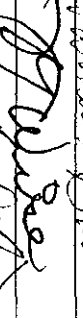
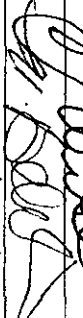
