{¶ 1} Staff served a notice of preliminary determination upon Vladislav Bubnovskiy in accordance with Ohio Adm.Code 4901:2-7-12, alleging a violation of the Commission's transportation regulations.

{¶ 2} On March 22, 2016, Vladislav Bubnovskiy filed a request for an administrative hearing in accordance with Ohio Adm.Code 4901:2-7-13.

{¶ 3} A prehearing conference was held on July 12, 2016; however the parties were unable to reach a resolution. Accordingly, a hearing should be scheduled on October 4, 2016, at 1:00 p.m., at the offices of the Commission, 180 East Broad Street, 11th floor, Hearing Room 11-C, Columbus, Ohio 43215-3793.

{¶ 4} Ohio Adm.Code 4901:2-7-14(E), provides that a respondent who requests an administrative hearing and fails to participate in the hearing proceeding shall be in default. The rule additionally states that a respondent in default shall be deemed to have admitted the occurrence of the violation and waived all further right to contest liability to the state for the forfeiture described in the notice.

{¶ 5} The attorney examiner notes that, in his request for an administrative hearing, Mr. Bubnovskiy requested the assistance of a Russian/English interpreter. If an on-site interpreter will be necessary for the hearing, Mr. Bubnovskiy or his counsel should contact the Commission by September 27, 2016.

{¶ 6} It is, therefore,

{¶ 7} ORDERED, That a hearing in this case be scheduled in accordance with paragraph 3. It is, further,

{¶ 8} ORDERED, That a copy of this Entry be served upon all parties of record.
