The certificate expired on July 24, 2016 and Celina seeks to extend the expiration date until August 31, 2016 to allow for the 30-day review process of its NEW application, which will be filed on/before August 1, 2016.

WHEREFORE, Celina respectfully requests that the Commission grant its motion to extend the expiration date of Certificate No. 04-114E(6) from July 24, 2016 to August 31, 2016.

## MEMORANDUM IN SUPPORT

The City of Celina ("Celina") was issued Certificate No. 04-087G to provide natural gas to its constituents as an Ohio government aggregator for the two-year period commencing July 24, 2014 and ending July 24, 2016. Unfortunately, due to an inadvertent administrative error, Celina failed to file its renewal application by the filing deadline of June 24, 2016. The Commission will receive a filed copy of Celina's NEW application by August 1, 2016. There have been no material changes in Celina's business practices as defined in Rule 4901:1:1-24-10 of the Ohio Administrative Code ("OAC").

Celina respectfully requests that the Commission extend Certificate No. 04-087G until August 31, 2016. Celina apologizes for this administrative oversight and pledges that all reports and certifications required by the Commission will be timely filed in the future.

The Commission has plenary authority to extend the expiration date of Celina's certificate for good cause shown. As demonstrated above, Celina's tardiness in filing its Renewal Application was solely due to an inadvertent administrative error. Moreover, Celina's business practices have not changed in any material respect since its last certification was filed in 2014. Consequently, Celina respectfully requests an extension of the expiration date of its certification.
