### Exhibit C

### Description of Transfer Control of GTE Wireless of the Midwest Incorporated

Cellco Partnership has three partners, one of which is GTE Wireless LLC ("GTEW"), a Delaware limited liability company.<sup>1</sup> GTE LLC ("GTE"), a Delaware limited liability company, owns all of the interests in GTEW. Both GTE and GTEW are holding companies with no employees. Cellco owns a number of subsidiary wireless providers, including GTE Wireless of the Midwest Incorporated ("GTEWM"), which is registered as a wireless provider with the Commission.

As a result of the proposed reorganization, Cellco will distribute GTEWM and two other affiliates that do not operate in Ohio to GTEW in partial redemption of its interest in Cellco. GTEWM will continue operating in Ohio as a sister affiliate to Cellco rather than a subsidiary. The reorganization has a target closing date of September 30, 2016.

The reorganization will not result in the elimination of or transfer of wireless identification registrations of any of the Verizon Wireless companies operating in Ohio. The reorganization will not result in the discontinuance of or a change in rates, terms, and conditions of any Verizon Wireless operating companies.

The transaction will take place at the parent-company level and will not involve any associated customer or asset transfers. The transaction does not entail "any material change in the rates, terms, and conditions of a service" or "any change in the company's operations that are not transparent to customers and may impact service." See O.A.C. Rule 4901:1-6-07. Accordingly, customer notice for the transaction is not required.

<sup>&</sup>lt;sup>1</sup> The other two partners are Verizon Americas Inc. and Bell Atlantic Mobile Systems LLC. While they are involved in this restructuring, only the portion of the transaction dealing with GTEW will impact any wireless subsidiaries registered and providing service in Ohio.
