Pursuant to the Commission Order filed on August 17, 2016, attached are the confirmation e-mails for the annual report filings, which FirstEnergy Solutions Corp. (FES) files on behalf of the government aggregation communities, as identified below. In addition, please note the following:

- (1) Annual Reports for Cardington Township (Morrow) – Certificate 15-938E, Village of Richwood, OH – Certificate 15-929E, and Village of West Farmington Ohio Trumbull County – Certificate 15-990E were timely filed under their previous certificates. They have since been filed under the current certificate.
- (2) Access for filing the Annual Reports for Smith Township – Certificate 12-524E, Pleasant Township – Certificate 12-551E, Village of Archbold – Certificate 10-262E, Village of Chippewa Lake – Certificate 10-301E, and Village of Green Camp – Certificate 15-984E was not initially available. However, FES has regained access and filed each communities' Annual Report.

On the "2015 Annual Report Delinquent List" attached to the Commission's Order, FES was incorrectly listed as the contact for City of Delphos – Certificate 12-540E (Delphos) and Prairie Township – Certificate 15-417G (Prairie). FES is no longer the CRES Provider for Delphos and never served as the Retail Natural Gas Supplier for Prairie. The appropriate contacts for these communities are filed under their respective dockets.
