NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio Transmission Company, Inc., (AEP Ohio Transco) proposes to relocate a 138-kilovolt (kV) transmission line in Pickaway Township in Pickaway County.

The purpose of the Delano-Scioto Trail 138-kV Transmission Line Relocation Project is to reroute an existing 138-kV transmission line mostly on property owned by the manufacturer the line is being rerouted to serve. The new line will provide power to a new Sofidel facility. The total length of this reroute is about two miles long. AEP Ohio Transco will build the new line using primarily single pole 138-kV structures. This project will be an approximate \$5 million investment by AEP Ohio Transco. Construction is anticipated to begin in September 2016.

The project is known as the Delano-Scioto Trail 138kV Transmission Line Relocation Project. AEP Ohio Transco filed a Letter of Notification with the Ohio Power Siting Board, under Case No. 16-1522-EL-BLN. This number should be included in all communications with respect to this project. The Letter of Notification to construct, operate and maintain this facility is pending before the board.

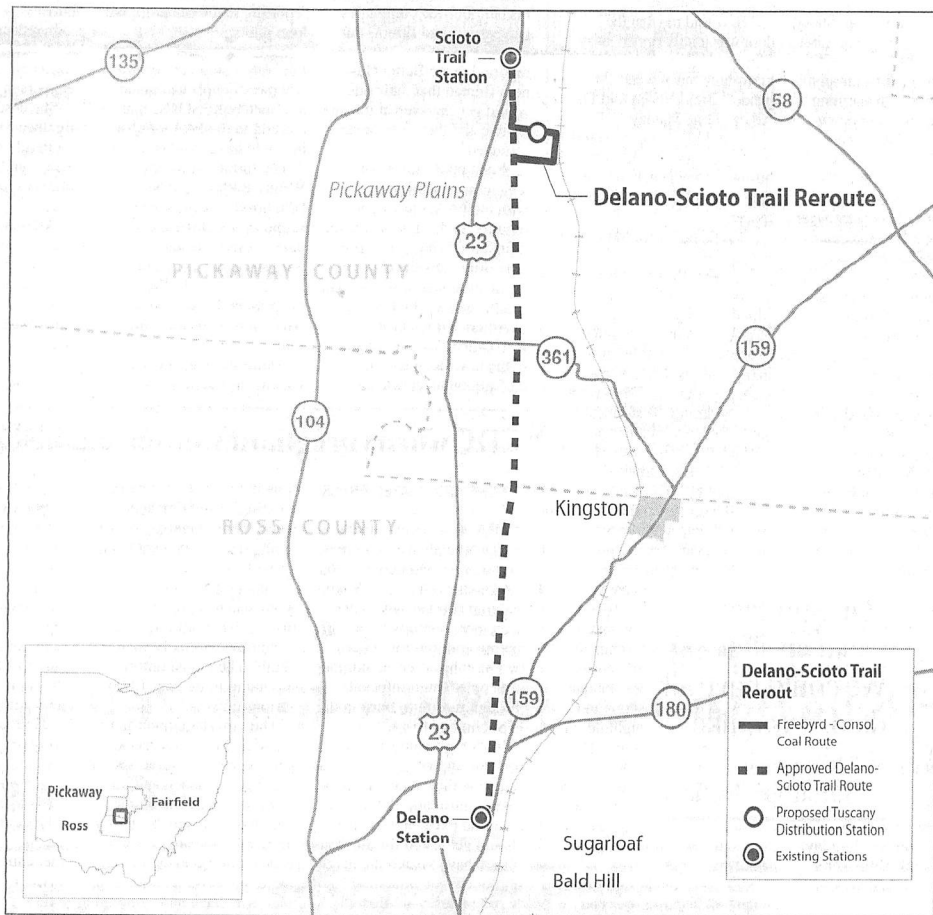
Petitions to intervene in the Letter of Notification will be accepted by the siting board up to 10 days following the publication date of this notice required by Rule 4906-2-12, Ohio Administrative Code. Petitions should be addressed to Ohio Power Siting Board, 180 East Broad Street, Columbus, Ohio, 43215-3793 and must cite Case No. 16-1522-EL-BLN.
