Pursuant to FCC 15-71, adopted June 18, 2015, Lifeline rule changes became effective on February 17, 2016. Under the revised rules, as of August 15, 2016, Carriers will no longer receive Lifeline reimbursement for any wholesale services to resellers, and incumbent LEC's are no longer required to offer their Lifeline services to resellers. This filing proposes changes to tariff provisions, compliant with these rule changes.

Part 54, Subpart E; the FCC's Lifeline reform order (Report and Order released February 6, 2012, WC Docket No, 11-42, et. al) and any subsequent clarifying orders; Section 4927.13, Revised Code; Rule 4901:1-6-19, Ohio Administrative Code; and, the Commission's nontraditional Lifeline service order (Finding and Order adopted May 23, 2012, Case No. 10-2377-TP-COI) and any subsequent entries and/or orders.

Pursuant to FCC order 15-71, adopted June 18, 2015, the Company does not provide Lifeline discounted service to resellers effective August 15, 2016.
