Date of Planned Service Discontinuance

Key Communications will discontinue providing long distance service on or after October 15,

2016, subject to regulatory approval.

Points of Geographic Areas of Service Affected

Key Communications will discontinue service in Michigan and Ohio.

Brief Description of Type of Service Affected

Key Communications is a switchless reseller of long distance service and will discontinue all long distance resale service.

Brief Description of the Dates and Methods of Notice to All Affected Customers

Key Communications notified customers by letter sent via U.S. Mail on December August 22, 2016. A copy of the letter is attached hereto as Attachment A.

Regulatory Classification of Carrier

Key communications is considered non-dominant with respect to the services to be discontinued.

Service

In accordance with Section 63.71 of the Commission's rules, copies of the Application are being sent, first class U.S. Mail to the Governor of the State of Michigan, the Michigan Public Service Commission, the Governor of the State of Ohio, the Public Utilities Commission of Ohio, and the Special Assistant for Telecommunications to the Secretary of Defense.

<u>Circumstances of Discontinuance</u>

Key Communications has determined it is reasonable and necessary to revise its business plan and discontinue the provision of service, including switchless domestic and international long distance telecommunications resale services. The discontinuance of services to customers will not adversely affect the public convenience and necessity. Customers have been given notice that affords them ample opportunity to transfer to a new carrier. Key Communications has provided the minimum 30-day notice required by the Commission for discontinuance of domestic and international services.

Conclusion

Key Communications believes that the proposed discontinuance of service is reasonable and necessary. As outlined herein, Key Communications has taken all reasonable steps, to the extent it is able to assure that the discontinuance of service is not disruptive to the present or future public convenience and necessity. Key Communications respectfully requests that the Commission approve its Section 63.71 Application and permit it to discontinue the provision of services to customers in Michigan and Ohio.
