Dear Examiner Parrot:

On June 7, 2016 in the above-captioned dockets, Ohio Power Company ("AEP Ohio" or the "Company") filed a Motion for a Consolidated Resolution of Multiple Proceedings, as well as Direct Testimony of William A. Allen and Direct Testimony of Kelly D. Pearce in support of the Motion. On August 29, 2016, an Attorney Examiner Entry established a procedural schedule directing AEP Ohio to file testimony in the above-captioned proceedings by October 4, 2016.

Because the Entry did not consolidate the "double recovery" issues with this remand proceeding and established a separate procedural schedule for those issues, AEP Ohio hereby withdraws the June 7, 2016 Direct Testimony of William A. Allen and Direct Testimony of Kelly D. Pearce from the above-captioned dockets.

Accordingly, AEP Ohio is filing revised Direct Testimony of William A. Allen as its direct case in the remand proceedings.

Workpapers supporting Mr. Allen's testimony provided to the parties on June 16, 2016 remain the same with the exception of those supporting Exhibit WAS-REM2, which has been updated to reflect an error identified during discovery. Revised workpapers for Exhibit WAS-REM2 will be served on the parties today.
