Memorandum in Support

Ohio Administrative Code (Ohio Adm. Code) 4901:2-7-13 provides that, following service of the Notice of Preliminary Determination (NPD), the respondent may file a request for administrative hearing.

In accordance with Ohio Adm. Code 4901:2-7-5, the Commission Staff (Staff) served a Notice of Apparent Violation (NAV) (attached as Exhibit A) upon the respondent, Map Transportation, Inc., alleging a violation of the Commission's transportation regulations. Following issuance of the NAV, it then appeared that Map Transportation, Inc., represented by Weddison Ebanks, asserted its rights under Ohio Adm. Code 4901:2-7-10 to request an settlement conference with Staff. There was no settlement reached between Staff and Weddison Ebanks regarding the violations charged against Map Transportation, Inc.

As a result, in accordance with Ohio Adm. Code 4901:2-7-12, Staff served a notice of preliminary determination (NPD) upon the respondent, Map Transportation, addressed to the attention of Weddison Ebanks at Map Transportations, Inc.'s address. Weddison Ebanks subsequently requested an administrative hearing and a prehearing conference occurred on September 22, 2016. At the prehearing conference, Weddison Ebanks admitted that he never represented Map Transportation, Inc. and that his responses to the NAV and NPD were his attempts to rectify the harm he believes he suffers as a result of the violation charged against Map Transportation, Inc.

Thus, it became apparent to Staff following the prehearing conference that Map Transportation, Inc. never responded to the NAV or the NPD – both of which only identify Map Transportation, Inc. – not Weddison Ebanks – as the respondent. As a result, Mr. Ebanks lacks standing under Ohio Adm. Code 4901:2-7-13 to challenge this matter, given that he is not a respondent.

Accordingly, this case must be dismissed.
