1 1. Q. Please state your name and business address.

2 A. My name is Jon C. Pawley, and my business address is 180 East Broad  
3 Street, Columbus OH 43215.

5 2. Q. By whom are you employed and what is your position?

6 A. I am employed by the Public Utilities Commission of Ohio (Commission)  
7 as a Utility Specialist 3 in the Siting, Efficiency and Renewable Energy  
8 Division of the Commission's Rates and Analysis Department. My  
9 position includes assigned duties by the Chairman of the Ohio Power Siting  
10 Board (Board) to investigate applications filed with the Board and assist in  
11 preparing staff reports of investigation.

13 3. Q. Please summarize your educational background and work experience.

14 A. I received an Associate of Applied Science degree in Architectural Tech-  
15 nology from SUNY Alfred State College in 1986, a Bachelor of Arts  
16 degree in Environmental Design from the University at Buffalo in 1991,  
17 and a Master of City and Regional Planning degree from The Ohio State  
18 University in 1993.

20 I have been employed by the Commission for roughly twenty years. Most  
21 recently, my responsibilities at the Commission have primarily involved  
22 social and cultural resource matters associated with site planning of major

1 utility facilities in the state of Ohio. I have also been the Staff project lead  
2 on numerous applications for a Certificate of Environmental Compatibility  
3 and Public Need before the Board. Additionally, I have over ten years  
4 experience in public and private sector development planning.

6 4. Q. Have you testified in prior proceedings before the Ohio Power Siting  
7 Board?

8 A. Yes. I have testified in the American Municipal Power, Inc. (AMP) gener-  
9 ating facility proceeding (Case No. 06-1358-EL-BGN); Buckeye Wind pro-  
10 ceeding (Case No. 08-0666-EL-BGN); Black Fork Wind Energy proceed-  
11 ing (Case No. 10-2865-EL-BGN); Vassell Station Project (Case No. 11-  
12 1313-EL-BSB); Biers Run-Circleville Project (Case No. 13-0430-EL-BTX)  
13 and the Biers Run-Hopetown-Delano Project (Case No. 13-0431-EL-BTX).

15 5. Q. What is the purpose of your testimony in this proceeding?

16 A. I am sponsoring the Staff Report of Investigation (Staff Report) that was  
17 filed in the docket of this case on October 28, 2016. I managed the Staff  
18 investigation and preparation of the Staff Report.

1     6.     Q.     What kind of a case is this?

2           A.     On June 22, 2016, Hog Creek Wind Farm, LLC (Applicant) filed joint  
3           applications to amend the Hog Creek Wind Farm I (09-0277-EL-BGN, as  
4           amended in 11-0757-EL-BGA and 11-5542-EL-BGA) and Hog Creek  
5           Wind Farm II (10-0654-EL-BGN, as amended in 11-5543-EL-BGA),  
6           respectively. The two project areas are both located entirely in Hardin  
7           County. On October 5, 2016, the Applicant supplemented these  
8           applications to modify the access road and collection line layouts.

10    7.     Q.     Do you have any changes or corrections to make to the Staff Report of  
11           Investigation?

12           A.     No.
