On 08/19/2016, a vehicle operated by CENTRAL OHIO FARMERS CO-OP, and driven by DAVID G ZIEGLER, was inspected within the State of Ohio. As the result of discovery of the following violations of the Commission's rules, Staff of the Commission timely notified DAVID G ZIEGLER (Respondent) pursuant to rule 4901:2-7-07, Ohio Administrative Code (O.A.C.), that it intended to assess a civil forfeiture against the Respondent in the following amount:
