**OHIO POWER COMPANY'S MOTION TO DEFER TARIFF FILING AND REQUEST
FOR EXPEDITED RULING**

Pursuant to Rule 4901-1-12, Ohio Administrative Code, Ohio Power Company ("AEP Ohio" or the "Company") respectfully moves the Commission to issue an order deferring the true-up tariff filing for the PPA Rider that is currently due on November 23, 2016 as referenced in the August 26, 2016 Entry in this proceeding. More specifically, the Company requests a two-week extension of the deadline until December 7, 2016. AEP Ohio requests that this motion be considered on an expedited basis pursuant to O.A.C. 4901-1-12(C). A memorandum in support of the items in this motion is attached.

MEMORANDUM IN SUPPORT OF THE MOTION

A true-up tariff filing for the PPA Rider is currently due on November 23, 2016 as referenced August 26, 2016 Entry in this proceeding. Ohio Power Company (“AEP Ohio” or the “Company”) submits that it is reasonable and efficient to defer the tariff filing. The Company is working diligently to present its ESP Extension filing (Case Nos. 16-1852-EL-SSO et al.) to the Commission on November 23, 2016, which is a complex and significant filing due on the same date. Given the impending Thanksgiving holiday, the Company requests an extension of the tariff deadline of two weeks. Because the November 3, 2016 Second Entry on Rehearing orders that the updated PPA Rider tariff be effective with the first billing cycle of January 2017, there will be sufficient time for Staff and intervenors to evaluate the Company’s filing under the deferred deadline. Accordingly, the tariff filing should be extended until December 7, 2016.

CONCLUSION

For the foregoing reasons, AEP Ohio requests that the Commission issue an expedited ruling to defer the November 23, 2016 deadline for two weeks until December 7, 2016.
