Recently Aes, the owners of the Dayton Power and Light, have informed the employees that they may be shutting down two of its coal fired power plants. It was stated the reason for this was the lack of financial stability in the electrical market due to falling power prices. If they plants were to close not only would the 500 to 600 direct employees be affected but also over 500 contractors working here daily would also. My greatest concern is the ramifications of the communities that surround these plants. DP&L is one of, if not the biggest, economic contributors to the local community though either its own or its employees. Schools, gas stations, restaurants, auto

dealerships, and retail stores would all be affected by closing of these two plants. It would set back the growth of these communities 50 to 60 years. A local manufacturing plant closed in nearby Maysville KY closed 3-4 years ago the communities still have not recovered. This would be a small sample size of what would happen if these plants are not to survive. The money that comes from these plants flow from Cincinnati to Ashland, and Columbus to Lexington covering several hundred miles. Please consider this in your decision in the rate case that AES has filed for.

My name is Mike Linville I'm from Brooksville Kentucky and proud union worker at AES/DP&L Stuart Station in southern Ohio.

It has come to our attention that our plant as well as the Killen station are subject to shutdown as soon as 2018 due to the vitality of the plants. Not ruling in favor of DPL would not only be impacting the close to 1000 workers on site each day, but also their families and communities in our surrounding area. These plants are the most up-to-date in scrubber technology and are as modern as they can be. So closing them really doesn't make much sense.

As is the case with close to 80% of the people that work here I am the breadwinner income. My spouse works but her wage doesn't not bring in enough to support our family and she is a nurse. This job is one of if not the best job in this area and shutting down the plant will cause many good working people to uproot their families to find work in other areas. In my particular case it will also take a qualified nurse away from the area.

That brings me to this area. The closure of these plants will have catastrophic consequences to this area. The local economy will take a sharp decline due to the lack of money to be spent in turn will cause the closing of many little stores and businesses. Our quiet little communities will turn into ghost towns. There are no local jobs left to turn to. School systems will take a huge hit. They will have to start cutting out programs to stay afloat. In turn cutting out programs will not give our children an outlet to express themselves leading to possible behavior issues as well as lack of learning.
