{¶ 1} Ohio Adm.Code Chapter 4901:1-39 provides that the Commission establish a procedural schedule for review of energy efficiency and peak demand reduction program portfolio plans. This matter is currently scheduled for hearing on December 21, 2016.

{¶ 2} On November 29, 2016, the Dayton Power and Light Company (DP&L or Company) filed a motion requesting that the deadline for the filing of DP&L testimony currently set for November 30, 2016, be postponed to allow the parties more time for settlement negotiations. DP&L also requests expedited treatment of its motion under Ohio Adm. Code 4901-1-12(C), and indicates that no party objects to this request. Further, DP&L requests that a conference be scheduled to provide a settlement status update and establish a new procedural schedule if necessary.

{¶ 3} As it appears that no party will be unduly prejudiced by an expedited ruling or the granting of this motion, the Company's motion will be granted and a conference call will be scheduled for Thursday, December 8, 2016, at 2:00 p.m. Parties are directed to dial 866-209-2820 and enter code 929 109 1549 to participate.
