#### AT&T OHIO'S RESPONSE TO OBJECTION

In order to expedite the Commission's resolution of this proceeding, AT&T Ohio<sup>1</sup> amended its tariff filing yesterday, December 1, 2016. With this amended tariff filing, the *only* changes proposed by AT&T Ohio are to the three rates that appear on the 3d Revised Sheet 28: (1) the pole attachment fee changes from \$2.48 to \$2.44; (2) the conduit inner duct rate changes from \$0.51 to \$0.55; and (3) the conduit full duct rate changes from \$0.77 to \$0.83. A copy of this revised tariff sheet is attached as Exhibit A.

AT&T Ohio discussed this amended tariff filing with counsel for the Ohio Cable

Telecommunications Association and understands that, in light of the amended tariff filing, the

OCTA will withdraw its objections to the AT&T Ohio tariff.

Pursuant to the November 30, 2016 entry in this case, the Commission adopted a 60-day automatic approval process for tariff amendment applications. Entry at ¶17. That process applies to this proceeding. As a result, AT&T Ohio's amended tariff application will automatically go into effect on January 1, 2017, unless the Commission suspends the application.

AT&T Ohio requests that the AT&T Ohio tariff revisions, as amended by its December 1, 2016 filing, be permitted to go into effect automatically on January 1, 2017.
