On October 3, 2014, Ohio Power Company (AEP Ohio) filed its Application to initiate the above-captioned proceeding. On December 14, 2016, Signatory Parties filed a Joint Stipulation and Recommendation (Stipulation), which was subsequently modified and adopted in the Commission's March 31, 2016 Opinion and Order and November 3, 2016 Second Entry on Rehearing. On December 7, 2016, AEP Ohio submitted proposed tariffs for the PPA Rider and in its December 21, 2016 Entry the Commission approved the proposed tariffs with corrections recommended by Staff. Accordingly, enclosed are the final tariffs to be effective with the first billing cycle of January 2017 that comply with the Commission's directives.
