We have submitted petitions signed by approximately 400 residents and all three of the Madison Township Trustees in protest to this rate increase. We have already absorbed the great costs of system improvements and Aqua has realized approximately \$500,000 annually in real property tax reductions. This proposed rate increase is not justified and the fact that the huge tax reduction did not result in a rate decrease is a potential indicator of a flawed rate system and lack of oversight by the PUCO.
