{¶ 1} Gov. Bar. R. XII(2)(A) provides rules governing eligibility to practice pro hac vice in Ohio. Pursuant to Gov. Bar. R. XII(2)(A)(7), motions for pro hac vice registration must be accompanied by a certificate of pro hac vice registration furnished by the Ohio Supreme Court Office of Attorney Services.

{¶ 2} On December 20, 2016, William L. Massey filed a correspondence in these cases providing notice of his withdrawal as counsel for COMPETE, which was an advocacy coalition that ceased operations in 2016 and no longer exists as an entity. While Ohio Adm.Code 4901-1-08(F) is a notice provision that only requires written notice to the Commission to withdraw from a case, the attorney examiner accepts the withdrawal of William L. Massey from these matters.
