**SPRIGG TOWNSHIP'S MOTION TO INTERVENE  
AND MEMORANDUM IN SUPPORT**

Sprigg Township ("Township") hereby respectfully moves the Public Utilities Commission of Ohio ("Commission") for leave to intervene in the above captioned matters pursuant to R.C. §4903.221 and Section 4901-1-11 of the Commission's Code of Rules and Regulations. The reasons for granting this Motion to Intervene are contained in the Memorandum set forth below.

**MEMORANDUM IN SUPPORT OF MOTION TO INTERVENE**

Township should be permitted to intervene in these matters pursuant to R.C. §4903.221 and the Commission's Code of Rules and Regulations contained in 4901-1-11.

Dayton Power and Light Company ("DP&L") operates a distribution and generation services facility ("facility") located within the boundaries of Township. DP&L recently announced that it intends to close the facility located in the Township which will have a detrimental economic impact upon the Township. Township is a political subdivision which is concerned about the potential economic impact any decision reached in this matter will have on its current

and future tax revenues generated from DP&L. Township wants to make sure that the interests and rights of the residents within the Township are properly heard, considered and protected throughout these proceedings.

Township has a direct, real and substantial interest in these proceedings. Any decision rendered by the PUCO in this matter will have some effect on the current and future tax revenues of Township. Additionally, the participation of Township in these proceedings will not cause undo delay, will not unjustly prejudice any existing party and will contribute to the just and expeditious resolution of the issues raised herein.


Therefore, Township is entitled to intervene in these matters with the full powers and rights granted by statute and by the Commission's Code of Rules and Regulations to intervening parties.


