We got there at 5:45 for a 6:00 presentation. The room Duke rented was full and we were told to wait for the 7:30 presentation. We could not wait that long. Five people rode together and some had other commitments. Duke should have anticipated this response and rented a larger hall. We went to another room with Duke representatives, and maps of the routes, the reps. were supposed to have answers and information. We did not find this to be true. We were sent from one station to another, with no one being able to answer questions and in some cases giving misinformation. Please require Duke hold another mandatory informational meeting with sufficient space and a question answer map room with company reps. who are able to answer
