## **ENTRY**

- $\{\P 1\}$  An Entry was issued on December 1, 2016, scheduling a February 2, 2017 hearing in this matter.
- {¶ 2} Timothy Michael contacted the attorney examiner on February 1, 2017, stating that illness would prevent him from attending the hearing on the scheduled date. Mr. Michael asked for a continuance of the hearing.
- {¶ 3} The attorney examiner notes that Mr. Michael had previously requested a continuance of a November 29, 2016 hearing. Given this factor, and Mr. Michael's current request, the attorney examiner emphasizes that, after rescheduling of the February 2, 2017 hearing, no further continuances will be granted, except for extraordinary circumstances.
- {¶ 4} Accordingly, the hearing shall be continued to February 16, 2017, at 1:00 p.m. at the Commission offices, Hearing Room 11-D, 11th floor, 180 East Broad Street, Columbus, Ohio 43215-3793.
- {¶ 5} Ohio Adm.Code 4901:2-7-14(E) provides that a respondent who has requested an administrative hearing and fails to participate in the hearing proceeding shall be in default. The rule further states that a respondent in default shall be deemed to have admitted the occurrence of the violation and waived all further right to contest liability to the state for the forfeiture described in the notice.
- $\{\P 6\}$  At the hearing, Staff must prove, by a preponderance of the evidence, that respondent committed the alleged violation, pursuant to Ohio Adm.Code 4901:2-7-20(A).

 $\P$  Following Staff's presentation of evidence at the hearing, it shall be the responsibility of the respondent, Timothy Michael, to present evidence in support of his contentions regarding the alleged violations in this matter.
