**OHIO EDISON COMPANY’S MOTION TO DISMISS**

Respondent Ohio Edison Company (“Ohio Edison”) moves, pursuant to Rule 4901-9-01(F), Ohio Administrative Code, to have this case dismissed on the ground that the Complaint has been satisfied. Complainant, through counsel, has represented to Ohio Edison that the case is resolved. Accordingly, no further action remains to be completed in this matter, and no further proceedings are necessary. Thus, Ohio Edison respectfully requests that the case be dismissed with prejudice.

Pursuant to Rule 4901-9-01(F), Complainant has twenty days after the service of this motion to file a written response indicating whether Complainant agrees or disagrees with the assertions contained herein and whether Complainant wishes to continue pursuit of this action. If Complainant does not file such a response, the Public Utilities Commission of Ohio may presume that the Complaint has been satisfied and, accordingly, dismiss the Complaint with prejudice. *See* Ohio Admin. Code 4901-9-01(F).
