- $\{\P 1\}$ Ohio Power Company d/b/a AEP Ohio (AEP Ohio or the Company) is an electric distribution utility, as defined in R.C. 4928.01(A)(6), and a public utility, as defined in R.C. 4905.02, and, as such, is subject to the jurisdiction of this Commission.
- {¶ 2} On November 23, 2016, AEP Ohio filed an application to extend, with certain modifications, the term of its current standard service offer (SSO) pursuant to R.C. 4928.141. The application is for an electric security plan (ESP) in accordance with R.C. 4928.143. The Company's current SSO term is scheduled to end May 31, 2018, and the ESP application proposes to extend the term through May 31, 2024.
