{¶ 1} The Dayton Power and Light Company (DP&L or the Company) is a public utility as defined under R.C. 4905.02, and, as such, is subject to the jurisdiction of this Commission.

{¶ 2} On February 22, 2016, DP&L filed an application for a standard service offer pursuant to R.C. 4928.141. DP&L's application is for an electric security plan (ESP) in accordance with R.C. 4928.143. Additionally, DP&L filed accompanying applications for approval of revised tariffs and for approval of certain accounting authority.

{¶ 3} By Entry issued on August 16, 2016, the attorney examiner issued a procedural schedule in this matter. Thereafter, the attorney examiner granted several motions to continue the procedural schedule and, by Entry on January 24, 2017, a hearing was scheduled for February 1, 2017.

{¶ 4} On January 30, 2017, a stipulation and recommendation between the Company and some of the parties was filed by DP&L. With the stipulation, DP&L also filed a motion for continuance. In consideration of the stipulation being filed, DP&L requested

the scheduled February 1, 2017 hearing be used as a scheduling conference and that the evidentiary hearing be continued. Accordingly, at the February 1, 2017 hearing, the attorney examiner granted the request for continuance and scheduled the evidentiary hearing for March 8, 2017. Testimony in support of the stipulation was to be filed by February 6, 2017, and testimony in opposition was to be filed by March 1, 2017. Additionally, discovery responses were shortened to seven calendar days.

{¶ 5} By Entry on March 1, the attorney examiner issued an Entry rescheduling the hearing until March 21, 2017.

{¶ 6} As discussions between DP&L and Staff continue, the attorney examiner finds it is appropriate to modify the procedural schedule. Accordingly, the evidentiary hearing should be rescheduled for April 3, 2017, in Hearing Room 11-A, at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, Columbus, Ohio 43215. Testimony in support of the stipulation should be filed by March 22, 2017, and testimony in opposition should be filed by March 29, 2017. Additionally, it is expected that parties will update the Commission regarding the progress of negotiations.

{¶ 7} It is, therefore,

{¶ 8} ORDERED, That the procedural schedule be modified as described in paragraph 6. It is, further,

{¶ 9} ORDERED, That a copy of this Entry be served upon each party of record.
