Duke's preferred route goes through a public parking lot on Cooper Road (next to Treo Realty and Computer DNA), all the way up to our fence, before making a right angle turn across the railroad, into a vacant lot. My complaint is why can they not make the turn well before reaching our property? I'm concerned about a few things. 1. My children's play set would be within feet of the pipeline. 2. If the ROW is 30 feet, it looks like we will be losing vegetation and possibly a fence that not only protects our children but blocks noise from the railroad that runs behind our property. 3. The increase in railroad noise from the loss of vegetation and/or fence, as well as the pipeline markers that will be visible from our property, will hinder the resale value and marketability of our home, which was built in 1939 and remains well-maintained. I question that it is really necessary to run this the pipeline so close to our home and many others. I hope the project will be denied. If it is not, it is my desire that an adjustment be made so that the route makes the right angle turn in the public parking lot or on Cooper Road, well before reaching our property line on Conklin Rd, Blue Ash.
