
**STATEMENT OF DUKE ENERGY OHIO, INC., THAT THERE ARE NO
OUTSTANDING ISSUES**

On November 22, 2016, Duke Energy Ohio, Inc., (Duke Energy Ohio or Company) filed a pre-filing notice relating to an adjustment of the Company's Accelerated Main Replacement Program rider (Rider AMRP). On February 13, 2017, the Company filed its application to adjust the Rider AMRP rates and to make tariff changes. A procedural schedule was issued by Attorney Examiner Entry, dated March 1, 2017 (Entry), establishing March 22, 2017, as the deadline for comments and intervention. The Entry also required the Company to file a statement, by March 24, 2017, informing the Public Utilities Commission of Ohio (Commission) whether all issues raised in parties' comments have been resolved. The Company hereby files such statement.

On March 22, 2017, Staff of the Commission (Staff) filed its comments and recommendations. No motions to intervene have been filed in these proceedings and the deadline for such intervention has passed. Staff has no objections to Duke Energy Ohio's Application and supporting documentation. Therefore, Staff recommends that the Commission approve Duke Energy Ohio's Application as filed.

Because no issues remain to be resolved and no stipulation is needed, the Company believes that a hearing in this case is unnecessary under the instructions of the Entry. Therefore, the Company respectfully requests that the Commission approve the Application, as filed.
