3. Columbia avers that the Complainant has failed to state reasonable grounds for a complaint against Columbia as required by Ohio Revised Code § 4905.26.
4. Columbia avers that the Complainant has failed to state a claim for which relief can be granted.
5. Columbia avers that it has complied with all applicable Ohio statutes, the Commission's rules and regulations and Columbia's tariff.

6. Columbia reserves the right to raise other defenses as warranted by discovery in this matter.
