MEMORANDUM IN SUPPORT OF MOTION TO AMEND APPLICATION

Rule 4901-1-06 and Rule 4901-1-12, OAC, provide the procedure by which a party may seek an order of the Public Utilities Commission of Ohio ("Commission") to amend an application. Vectren, through this Motion, seeks to amend its Application to correct the calculation for the projected sales volumes of gas stated in Exhibit C of the Application and the resulting rate stated in the proposed tariff sheet.

Vectren filed its Application on March 16, 2017. After it filed its Application, Vectren determined that the calculation of the projected sales volumes in Exhibit C of Attachment 1 contained an error. Correcting for the error results in a change in the rate calculated in Exhibit A and the proposed tariff sheet.

For the reasons stated above, Vectren requests that the Commission grant its motion to amend.
