NOTICE OF INTERVENTION OF THE CITY OF DEER PARK

Pursuant to R.C. 4906.08(A) and O.A.C. 4906-2-12(A)(1), now comes John Donnellon, the Mayor of the City of Deer Park, Ohio, ("City") and files this Notice of Intervention in the above captioned case.

O.A.C. 4906-2-12(A)(1) provides:

The chief executive officer of each municipal corporation and county and the head of each public agency charged with the duty of protecting the environment or of planning land use in the area in which any portion of such facility is to be located may intervene by preparing and filing with the board, within thirty days after the date he or she was served with a copy of the application under division (B) of section 4906.06 of the Revised Code, a notice of intervention containing the following information:

- (a) A certification or affirmation as to the legal title and authority of such official.
- (b) A statement demonstrating the fact that all or part of the proposed facility is to be located within the area under the jurisdiction of such official.
- (c) A statement indicating that such official intends to intervene in the proceedings, together with the grounds for which intervention is sought.

As set forth in the attached Exhibit A, John Donnellon holds the legal title and authority of the Mayor of the City of Deer Park, Ohio. He serves as the chief executive officer for the City.

With respect to O.A.C. 4906-2-12(A)(1)(b), a portion of the proposed C314V Central Corridor Pipeline Extension Project ("Project") is to be situated within the Deer Park city limits near the intersection of Blue Ash and East Galbraith Roads.

This proposed pipeline route poses potential disruption to future roadway improvements in the City, including the planned Blue Ash Road Improvement Project. It could also impact on the ability to further develop several properties near the intersection of Blue Ash and East Galbraith Roads that the City recently used grant funds to help clear.

The intersection of Blue Ash and East Galbraith Roads is a busy traffic hub and represents one of the main access points to Deer Park. The City has concerns about the impact on traffic flow in light of the planned route and construction timelines, as well as the potential detrimental impact on local businesses. Additionally, Deer Park is a "walking school district" and there are concerns regarding the safety of the students in the vicinity of the proposed construction.

Lastly, with respect to O.A.C. 4906-2-12(A)(1)(c), Mayor John Donnellon, on behalf of the City of Deer Park, intends to intervene in this proceeding.

Deer Park intervenes as a party to this proceeding to protect the interests of the City and the health and welfare of its residents. In addition, the City anticipates that through its intervention it may act with other jurisdictions to represent regional interests common to the City and other political subdivisions including an evaluation of Project need and safety issues. Deer Park has a direct and substantial interest in this proceeding.

The City intends to express concerns with the environmental, logistical, and operational effects of the Project upon the City and its residents and to participate in all facets and details of the Board's review of the proposed Project as it relates to the City and its residents. The City believes that its participation in this proceeding is a matter of public importance citywide and regionally, and that the City's knowledge, among other things, of its roadways and rights-of-way will contribute to an equitable resolution of the issues involved.
