



CC Docket No. 02-33 - Notice of Permissive Detariffing of WBIAS

April 10, 2017

The Ottoville Mutual Telephone Company (the "Company") hereby provides notice that it intends to cease offering wireline broadband internet access service (WBIAS) on a tariffed basis. Effective July 1, 2017, the Company will begin offering WBIAS on a Title II, common carriage, permissive detariffed basis pursuant to paragraphs 90 and 94 of the Federal Communications Commission's Wireline Broadband Order.¹ The geographic areas affected are the entirety of the Company's study area where DSL is technically feasible.

Today, this service is provided to only one customer, The Ottoville Mutual Telephone Company's ISP division. The ISP purchases WBIAS as a wholesale input to its broadband Internet service, which is sold to residential and business customers. End user service will not be affected by permissively detariffing the offering by the Company. As stated in the attached customer notice, the Company will continue to offer existing ISP customers wireline broadband Internet access service pursuant to current terms and conditions until the end of their current term or upon replacement with a Broadband commercial agreement.

Effective July 1, 2017, the Company's rates, terms and conditions for its permissively detariffed WBIAS will be available on its website (www.ottovillemutual.com) and in printed copy during normal business hours at its business office located at 245 W. Third Street, Ottoville, OH 45876.


Our records indicate that The Ottoville Mutual Telephone Company's ISP Division is currently purchasing wholesale wireline broadband Internet access services from The Ottoville Mutual Telephone Company pursuant to the terms of NECA Tariff FCC No. 5. This letter is to inform you that The Ottoville Mutual Telephone Company will no longer offer such wholesale wireline broadband Internet access services pursuant to tariff effective July 1, 2017. On and after July 1, 2017, services will be made available to you on a common-carrier, non-tariffed basis.

The Ottoville Mutual Telephone Company will make physical copies of its rates, terms and conditions for its non-tariffed wireline broadband Internet access transmission service available for public inspection during normal business hours at its office located at 245 W. Third Street, Ottoville, OH 45876 and on its website at www.ottovillemutual.com.

The actions described above are taken in accordance with the FCC's Report and Order (FCC 05-150) released September 23, 2005 in CC Docket No. 02-33. In the order, the FCC determined that facilities-based wireline broadband service providers could offer their services on a common-carrier, permissively de-tariffed basis.
