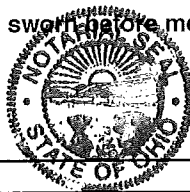

Carroll County Energy LLC has filed an application with the Ohio Power Siting Board in Case No. 17-0925-EL-BGA seeking a Third Amendment to its Certificate of Environmental Compatibility and Public Need Issued for a Natural Gas-Fired Combined Cycle Generating Facility to be located in Washington Township, Carroll County, Ohio. The purpose of the requested Third Amendment is to install four Caterpillar 3.9-MW black start emergency generators in a small building on the facility property.
