COMMENT DESCRIPTION:

Reading in our local newspaper, I am informed that American Electric Power has a rate increase request before your commission, regarding the "fixed" customer charge. The increase is for \$5 per month for both 2017-2018, making every bill increase by \$10 per month. This is not warranted, given the reasons cited in the article (Parkersburg News and Sentinel by Janelle Patterson), in my opinion. I DO NOT WANT to see rate increases based on alternative sources of power generation. Build new coal, oil, or gas generation plants. Didn't these folks hear about the "NEW SHERIFF IN TOWN", who doesn't subscribe to the previous administration's nitwit ideas about climate change/man responsibility. Justify your increases by building new clean generation facilities on fossil fuel sources, which are dependable 24/7/365(6)! In addition, the sources should employ Ohio sources for fuel, if possible (lowest cost

availability). You may say why do I care? Although I must get some help (HEAP) for my energy use, I don't want to see unnecessary tax dollars spent on my behalf. In this HUD housing unit, most of the people qualify for HEAP assistance. Passing along the cost is not a monetarily efficient idea. Making wise investments by the utility company is a much better alternative. I WANT to see competition in fuel alternatives. However, government should not be interfering in market pricing. I can recall the time (1950's) when the gas and electric companies actually competed for the customer's use. Greater usage of power was rewarded by lower unit cost. It is high time, this common sense system was returned. Most of the alternative fuel advocates DO NOT CALCULATE the true costs for those fuels (why they need a subsidy?).
