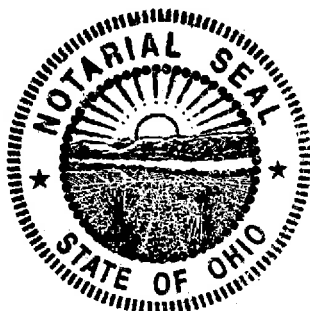

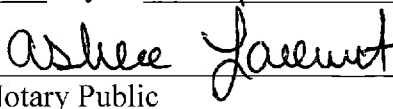

FirstEnergy and its affiliates invite you and members of the community to learn more about the proposed Springfield Area Reinforcement Project at a local public information meeting on Wednesday, October 26.

The proposed transmission project will enhance electric service for Ohio Edison customers in the area, as well as reduce the risk of a regional outage, improve voltage stability, and allow for future load growth as new businesses and homes are built. At the meeting, FirstEnergy will discuss the project and seek your input on a series of potential routes for new transmission lines. The meeting will be held at the following place and time:

Wednesday, October 26
6 to 8 p.m.**

The project consists of three main components:

1. Expanding and converting an existing 69-kilovolt (kV) substation in Moorefield Township to support both 138-kV and 69-kV operation.
2. Connecting the existing Clark-Urbana 138-kV transmission line to the expanded Substation by extending the line for an additional two miles.
3. Extending the East Springfield-Tangy 138kV transmission line an additional 5.5 miles from the east to the expanded substation.

FirstEnergy will seek a Certificate of Environmental Compatibility and Public Need from the Ohio Power Siting Board (OPSB) in order to build the project. For new transmission lines, the OPSB requires an applicant to submit information on both a preferred and alternate route. FirstEnergy has carefully studied the general area to identify potentially sensitive areas and land uses, and has identified two potential routes for each of the two transmission lines that will be presented at the

meeting (see map). This letter is being sent to you as a property owner with a parcel on or near one of the transmission line routes under consideration.

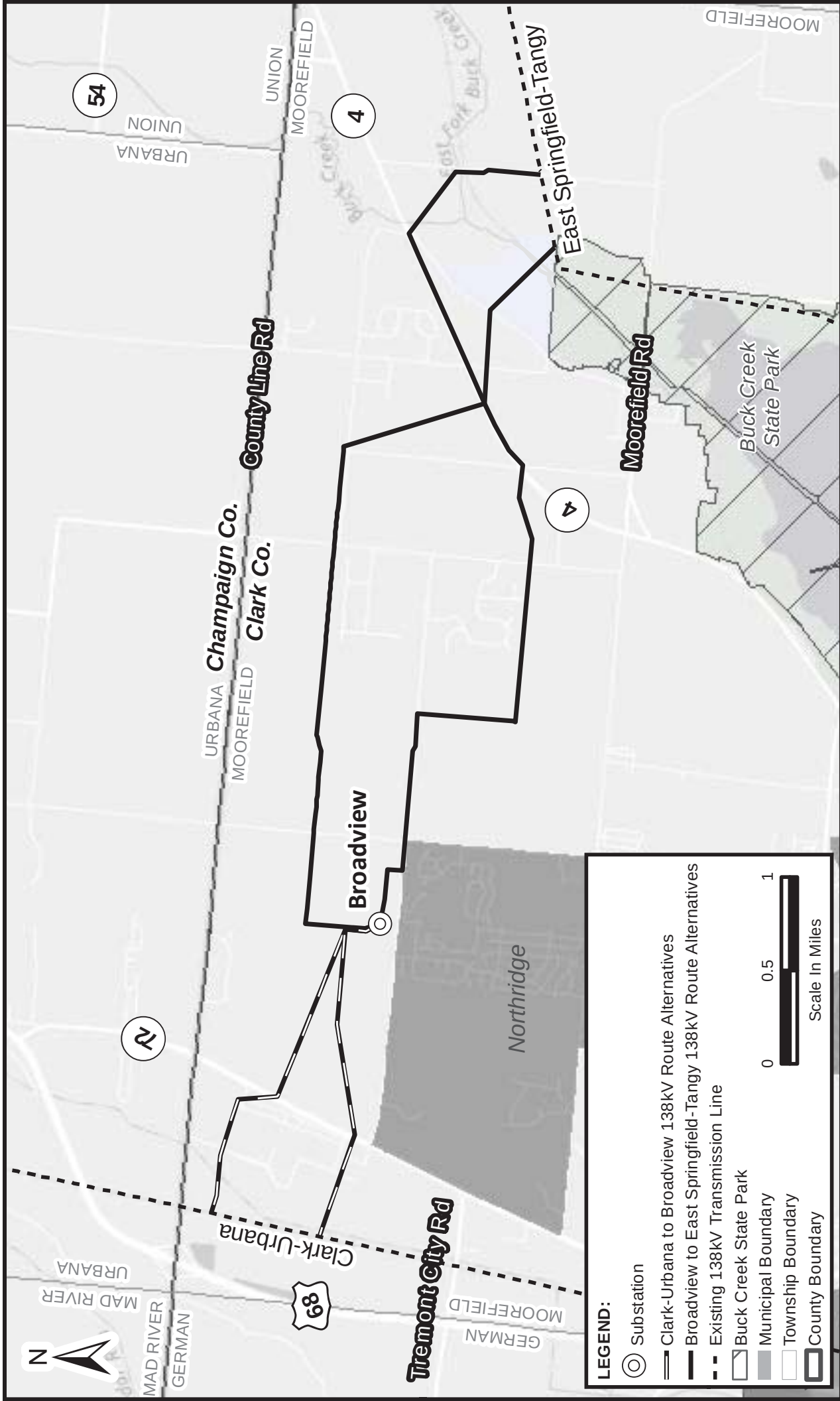
