



We are notifying you that Ohio River Partners Shareholder LLC ("Ohio River Partners") has filed a Letter of Notification application with the Ohio Power Siting Board in Case No. 17-1091-EL-BLN to construct the Hannibal Port Power Project. We previously sent you a letter dated March 9, 2017 about this project. The Hannibal Port Power Project is a proposed 485-megawatt (MW) state-of-the-art natural gas-fired combined cycle electric generating facility to be sited on approximately twenty acres in an unincorporated area of Ohio Township, Monroe County, Ohio. The Project will be developed completely within the boundaries of an existing approximately 200-acre industrial facility that was formerly the location of the Ormet Primary Aluminum Corporation's Hannibal, Ohio smelter.

A public information meeting was held on March 27 at 6:00 PM at Monroe Central High School, 469 Lewisville Road, Woodsfield, Ohio 43793. The Letter of Notification application was filed on April 28, 2017. The Staff of the Ohio Power Siting Board will conduct an investigation and issue a report. A copy of the Notice of the Proposed Major Utility Facility, which will be published in the May 4, 2017 edition of The Monroe County Beacon, is also enclosed.

You may file a motion to intervene or provide comments to the Ohio Power Siting Board by May 15, 2017 by including the case number above and sending the motion to intervene or comments to Ohio Power Siting Board, Docketing Division, 180 E. Broad St., 11th Floor, Columbus, Ohio 43215-3793.

NOTICE OF PROPOSED MAJOR UTILITY FACILITY

Ohio River Partners Shareholder LLC is proposing to construct the Hannibal Port Power Project in Hannibal, Monroe County. The proposed project consists of a 485-megawatt state-of-the-art natural gas-fired combined cycle electric generating facility proposed within an approximately 50-acre property. The Hannibal Port Power Project will respond to regional energy needs as well as potential local energy needs associated with ongoing industrial development located within the general vicinity.

The Hannibal Port Power Project is proposed to be situated on industrial property between Ohio Route 7 and the Ohio River. Access to the portion of the industrial property within which the Hannibal Port Power Project area is to be located is provided off State Route 7 from an entrance located at the northeastern end of the industrial property. A map showing the location and general layout of the proposed facility is included in this notice.

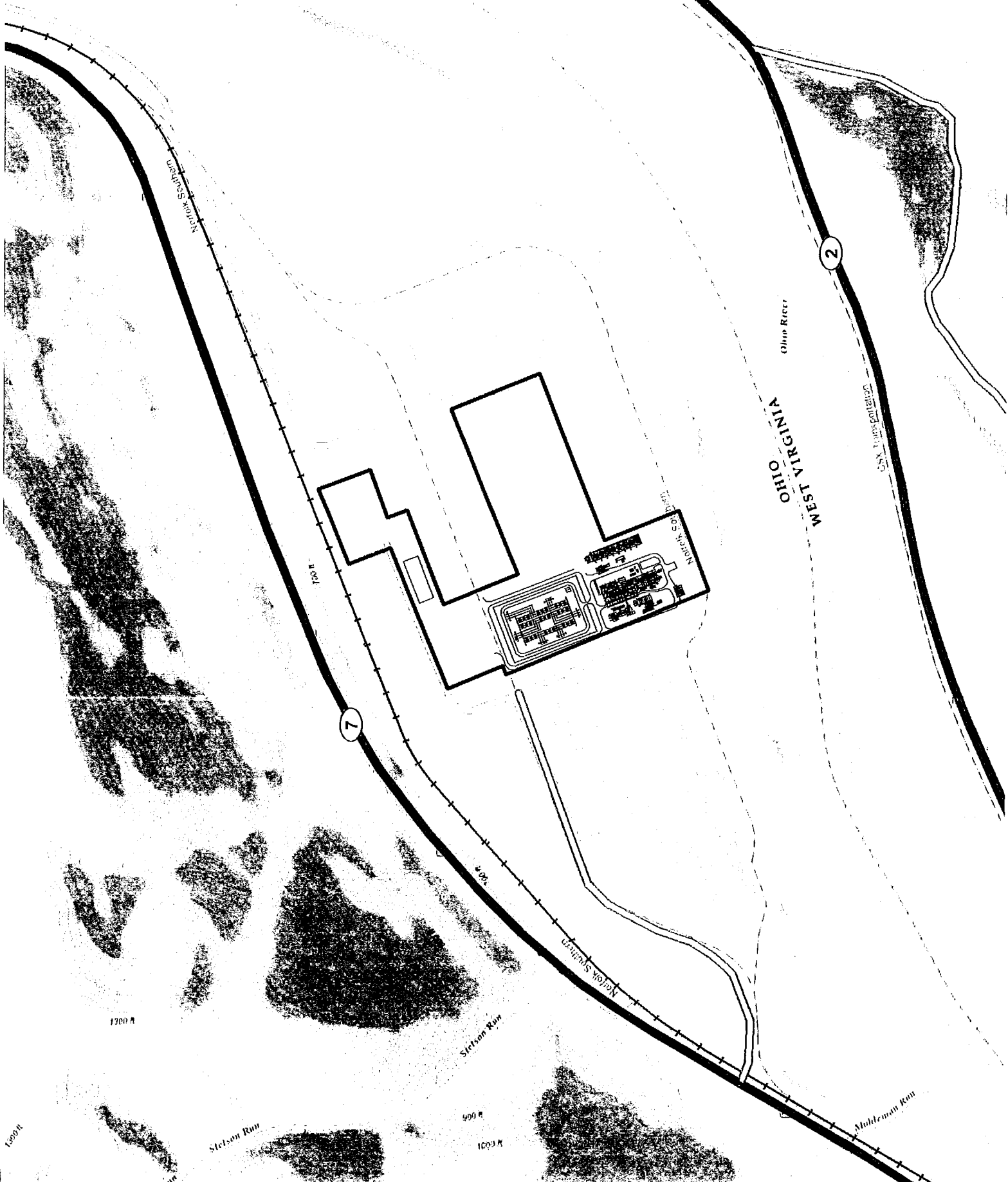
Ohio River Partners Shareholder LLC has filed with the Ohio Power Siting Board a Letter of Notification to construct, operate, and maintain the Hannibal Port Power Project in Case No. 17-1091-EL-BLN, which is now pending before the Board. Monroe County Commissioners Schumacher, Davis, and Price, as well as the Monroe County's Economic Development representative, have received a copy of the Letter of Notification in accordance with the Board's rules. A copy of the Letter of Notification was also sent to the Ohio Township Trustees (Eggleston, Dennis and Matusik). A copy of the Letter of Notification was also served on the Monroe County District Library located at 96 Home Ave., Woodsfield, Ohio 43793.
