## LIMITED COMMENTS OF PJM INTERCONNECTION, L.L.C.

PJM Interconnection, L.L.C. ("PJM") submits these limited comments to assist the Public Utilities Commission of Ohio's ("Commission's") determination in this proceeding. PJM's expressed interest was to ensure that Dayton Power and Light Company's ("DP&L's") Reliable Electricity Rider ("RER") would not negatively impact PJM's ability to administer efficient and competitive wholesale energy, ancillary service and capacity markets, nor PJM's ability to maintain the reliability of the transmission system in the PJM Region, which includes the state of Ohio.<sup>1</sup>

PJM's concern in this proceeding is limited to the potential impact on the wholesale market of the RER given DP&L's share of the Killen and Stuart generating plants (Killen combustion turbine and unit 1, and Stuart units 1, 2 and 3). The RER originally proposed by DP&L was withdrawn by DP&L and is not included in the March 14, 2017 Stipulation and Recommendation in the proceeding.

On March 17, 2017, DP&L and the joint owners of the Killen and Stuart units submitted formal notification to PJM of the planned deactivation of the specific Killen and Stuart units which were the subject of PJM's concern. Such notification was provided to PJM in compliance with PJM's Open Access Transmission Tariff rules. According to such notice, these units plan to retire on or about June 1, 2018. Accordingly, PJM does not take a position on the Stipulation and Recommendation.
