MEMORANDUM OF INTERVENORS MURRAY ENERGY AND CITIZENS TO PROTECT DP&L JOBS IN OPPOSITION TO MOTIONS OF INTERVENOR SIERRA CLUB TO STRIKE PORTIONS OF THEIR POST-HEARING BRIEF

Intervenor Sierra Club has filed motions to strike those portions of the Post-Hearing Brief and the Reply Brief (together, the "Briefs"), respectively, of Intervenors Murray Energy, Inc. and Citizens To Protect DP&L Jobs that reference Dayton Power & Light's representations made to the Commission in its Original Application¹ concerning the devastating economic impacts that would ensue if DP&L were to shutter its coal-fired generating plants. The Sierra Club contends that the Commission should strike Intervenors' references to DP&L's representations to the Commission in its Original Application because that Application has been "withdrawn." However, that is not true.

DP&L filed its Original Application on February 22, 2016. On September 23, 2016, DP&L filed a "Notice of Withdrawal of Reliable Electricity Rider," pursuant to which DP&L provided notice of its "withdrawal of its request in this case for a Reliable Electricity Rider ('RER')." See Exhibit A attached hereto. That filing did not purport to withdraw the Original

Application in its entirety. Moreover, DP&L's September 2016 filing says <u>nothing</u> about the representations it had made in its Original Application concerning the devastating economic impacts that would be caused by the shuttering of its generating plants.

DP&L's Original Application eloquently details the pervasive and devastating economic effects that the shuttering of its generating assets would have for local residents and others throughout the State of Ohio. The Sierra Club cannot suggest that DP&L was misleading the Commission by those representations. The Sierra Club cannot "un-ring the bell." The Sierra Club's motions to dismiss are without merit and should be denied.
