Dear Members of the OPSB: Recently, three letters of support of this pipeline have been submitted. The letters I refer to come from the communities of Woodlawn and Mariemont and Ohio State Senator Steve Wilson. I would like to take a moment to point out that these two communities, as well as State Senator Wilson's District, are unaffected by the presence of this pipeline. While these communities and the State Senator are certainly entitled to their opinions regarding the Duke Energy transmission pipeline, these communities and the State Senator's District do not have to bear the impact and potential safety consequences of the pipeline. Indeed, if these communities support the pipeline, perhaps Duke Energy could re-route the pipeline through the communities that support building it. As you will note from the great outpouring of opposition to building the pipeline, those who will bear the brunt of the safety

implications argue not our backyard, not their backyard, indeed, in no one's backyard should this pipeline be built. Again, I urge you to oppose this pipeline and deny approval. Sincerely,
