RE: 16-0253 GA-BTX Duke Energy Pipeline Extension

To the Members of the Ohio Power Siting Board:

On July 12, 2016, I wrote to you on behalf of Standard Textile and our President Gary Heiman regarding our company's strong opposition to the proposed Duke Energy "Green Route" for a new 30" natural gas pipeline.

It is my understanding that the "Green Route" remains under consideration as a possible pipeline route. Please confirm whether my understanding is correct and advise when the final decision will be made.

Locating the pipeline along the "Green Route" would have a negative effect on current Reading employers such as Standard Textile as well as on potential future Reading employers and would thereby undermine the future economic development for the city. As proposed, the pipeline would be built just east of the existing 50-acre Reading Life Sciences Campus which adjoins Standard Textile's world headquarters and is comprised of three major biotechnology firms employing over 1,000 jobs. It would also traverse the 14-acre Reading Life Sciences Expansion Site which is currently being considered for a major biotechnology project that will create significant investment and jobs for the City of Reading and the State of Ohio.

Locating a 30" natural gas pipeline adjacent to this biotechnology hub could significantly jeopardize the safety and integrity of the Life Sciences Campus and have an adverse impact on our operations in the event of a safety incident.

To protect the safety of life, health and property for our operation as well as other nearby businesses and residents, we reiterate our strong desire that the Ohio Power Siting Board eliminate the "Green Route" as a location for the 16-0253 GA-BTX Duke Energy Pipeline Extension.

For the past five years, I have been the Director of Emergency Services for Warren County Ohio, responsible for Emergency Management as well as Emergency Communications (911 dispatch).
