

MEMORANDUM IN SUPPORT


NEP Energy Services Ltd. was issued its Certificate No. 12-490E by the Public Utilities Commission of Ohio in April of 2012 in Case No. 12-818-EL-AGG. A renewal certificate was issued in the same case in April of 2014. However, NEP Energy Services Ltd. did not file a renewal certificate application in 2016 and its Certificate No. 12-490E was cancelled in September of 2016.

Because its certificate was cancelled in September of 2016, NEP Energy Services Ltd. was uncertain regarding the obligation to file a 2016 Annual Report. Because of that uncertainty and the press of other business, it did not file its 2016 Annual Report by the May 31, 2017 deadline. It now understands that it should have filed its 2016 Annual Report by May 31; it has now filed its 2016 Annual Report electronically on June 7, 2017.

This 2016 Annual Report will be the final annual report of NEP Energy Services Ltd. as its certificate has been cancelled and it has not engaged in the business of being a power broker or aggregator in Ohio.

NEP Energy Services Ltd. regrets its delay in filing and respectfully requests that the Commission grant its motion for waiver and accept the 2016 Annual Report as its final annual report which was filed electronically on June 7, 2017.
