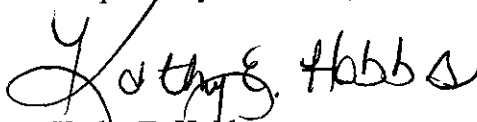

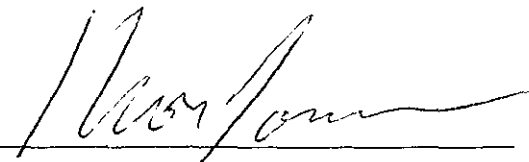

AFFIDAVIT

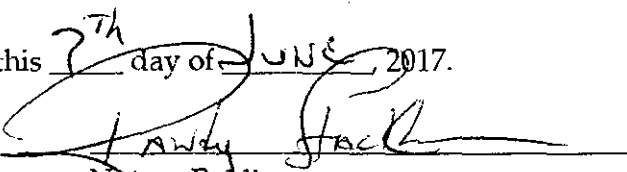
Affiant, Aaron Jones, having first been duly cautioned and sworn, affirms, declares and says the following:
