



Affiant **Richard R. Rostorfer**, having first been duly cautioned and sworn, affirms, declares and says the following:


1. I am the duly appointed agent/representative of **Sherwood Mutual Telephone Association, Inc.** and am authorized to make this statement on the company's behalf.
