A few months ago Haynes Goddard (retired UC professor) wrote an opinion piece in the Cincinnati Enquirer regarding the Duke pipeline proposal. He raised several questions that need to be answered for the public to be well informed.

He asserted that Dukes own estimate of gas demand in the area is flat and the major increase in natural gas transmission will eventually be used to ship gas out of the state. It is easier for Duke to get permission for this pipeline within the state of Ohio than it would be from federal regulators if the pipeline was part of an interstate project. I find it hard to believe that you are not aware of this but haven't heard a response to this issue. Duke's long term expectations for this pipeline are a critical issue and residents should know if Duke is trying to manipulate the regulatory process.

COMMENTS: Please consider the Danger 80 year old increasingly fragile laterals into homes, schools, shopping centers pose during construction.

Heavy machinery will be compacting soil above around and below mains and laterals which are up to 80 or more years old. Laterals which are more subject to cracking with age.

Case In Point: recently in Texas and generally elsewhere old mains and laterals have cracked when disturbed. In Texas the leak was not apparent at the location of the crack, but moved along the outside of the pipe into the the house which then exploded damaging neighbor structures which were not as close to each other as many in the Duke Study. Murphy's law is clear on this, "What ever can go wrong will go wrong," and the corollary in this case "And it will explode next to a school on a school day, or a shopping center during peak hours, and ..."

This Pipe Extension was designed on a computer. In my thirty years in the computer industry I have experienced Murphy and his Law too many times. A misplaced decimal has lost companies millions of dollars and cost lives. Think about how reliable your computers have been.

Remember Bruce Ismay who was in a similar position as you the board and Duke. In the transportation business and not required to consider all the human lives involved. He did not bother with that issue in his quest for company and personal profits. The 1,500 lives lost weighed so heavily on him, because of not considering that ethical responsibility he remained in Seclusion for the rest of his life.

Please, I do not want you or any one associated with this project to suffer this same tragic change in their lives.

Dear Members of the Ohio Power Siting Board,

I will not be able to attend the June 15 public hearing, but I represent many Hamilton County residents in my 9th Ohio Senate District who are concerned about the pending application for the construction of the massive natural gas pipeline by Duke Energy of Ohio. Please include this brief statement in the record.

Rates paid by my constituents would be increased to support the \$100,000,000 or more which Duke says will be cost of this 14-mile high pressure pipeline. I ask that you carefully examine the claims of a need for this project and give these citizen concerns the full and fair consideration when considering this case, in light of the availability of upgrades to the existing propane plants, upgrades that would cost our residents perhaps \$12,000,000. The pipeline's massive cost would be a burden on many residents' ability to pay for gas, while the same outcome could have been achieved at a lower cost.

I am most concerned about the serious fire and explosion danger posed by this shallow, high pressure, 20 inch diameter, and 400-500 pounds per square inch pipeline. I urge that you give these concerns the full and fair consideration as well. Residents are concerned that their suburban communities and shopping areas, what the federal government calls "High Consequence Areas," will be at high risk of accidental breaks. These intensely busy residential areas are not safe locations for very large gas pipelines. The environmental and human consequences of accidental damage would be very grave. That risk is best handled by requiring Duke to seek an alternative gas source through upgraded peaking plants without the huge cost and disruption of this dangerous pipeline.

Dear Ohio Power Siting Board,

As a resident of Other and concerned citizen, I am writing you to register my opposition to Central Corridor Pipeline Extension Project (Reference No. 16-253- GA-BTX).

We are really concerned and worried about this pipeline. Evendale has been our home for 18 years and has been a great place to live and raise our 2 kids. This proposed pipeline has caused a huge upheaval in our community. Evendale makes a huge effort to keep our community looking its best with trees and other landscape along Glendale-Milford and Reading Roads. If this pipeline is built in our community it will decimate all the trees and landscaping that the village and the residents have worked so hard to keep up and make Evendale a beautiful and nice place to live.

We were shocked to hear that Duke Energy wanted to build this pipeline directly in a highly populated areas near Evendale School, a college, expensive homes, community centers, hospitals, businesses and shopping areas. I question whether this type of pipeline is really necessary and wonder why it is not being built in a more rural area that is not a central thoroughfare in a community.

This type of pipeline is a very dangerous and should never be built in any densely populated area. The danger zone around a pipeline of this size and pressure is at least 1/3 mile. The heat from a high-pressure pipeline blast is immediate and intense. My family and many others who live in Evendale and the surrounding areas are within 1/3 mile of the pipeline are at risk of being burned from radiant heat or killed by a blast.

We don't want our communities to be another San Bruno, California where in 2010 a high pressure pipeline burst and the explosion and fire killed eight people and injured 58 while destroying 38 homes and damaging 70 others. It is scary that the community is still recovering from this accident and it could happen again.

It is apparent that pipeline safety precautions are inadequate and Duke does not have the experience or the skilled workforce necessary for this project and may not be able to 'buy' it due to industry labor shortages. Numerous sources, including the 2014 Report by US Office of Inspector General indicate government regulations are insufficient. In addition, the PHMSA, which is responsible for pipeline safety is understaffed and does not provide sufficient oversight. It concerns us that Duke has not demonstrated a commitment to safety or industry best practices. Duke has been cited many times by OSHA for not following workplace safety regulations and has also already been fined for a gas explosion in Lebanon, OH as well.

Is this pipeline really necessary? Pipeline incidents happen two times a day on average in the United States, and more than 11,000 such incidents have occurred over the past 20 years. Backhoes, weld failures and even Mother Nature compromise pipelines, regularly. While significant damage is rare, so too are high-pressure, large-diameter lines in densely-populated areas, like the one Duke Energy has proposed in greater Cincinnati. If this pipeline isn't truly necessary to meet this area's energy needs, why should residents bear the risk?

We are asking you to vote against this pipeline. It just does not make sense in this area and is unnecessary.

Unlike delivery pipelines, this pipeline will be under up to 500psi pressure and an accident or rupture could cause

injuries, death and destruction of property within a radius of 1000 feet.

I ask you to oppose this pipeline and encourage both Duke Energy and the Ohio Power Siting Board to reject this pipeline

Subject: Written Comments of Concern Regarding Proposed Duke Central Corridor Pipeline

To the Administrative Law Judge:

Thank you for holding the public hearing on the proposed Duke Energy Pipeline. I am unable to attend the hearing to verbally express my concerns, so I am offering my comments in written form. These comments are respectfully submitted below.

"As Superintendent of Sycamore Community Schools, a public school district located in north central Cincinnati; specifically serving students in the cities of Blue Ash, Montgomery and Symmes Township, I feel obligated to express my concerns on the proposed Duke Central Corridor (Case Number 16-0253-GA-BTX) Extension Gas Pipeline.

Sycamore Community Schools serves approximately 5,400 students in grades PK - 12 in seven schools. As the state designated authority charged with reviewing, and ultimately ruling on, the coming permit from Duke Energy for the proposed natural gas lines, it is important for you to understand and carefully consider my reservations regarding the locations of these proposed natural gas pipelines.

As you may recall and certainly have in your files, I submitted a letter in May of 2016 expressing my concern at the proximity of at least two of the proposed routes to several of our schools. Through a series of public meetings, I was gratified that you listened to community members and made alterations to the proposed routes. However after reviewing the details of these revisions, I remain concerned by the distance of your preferred route to two of our schools; namely, Sycamore High School and Edwin H. Greene Intermediate School.

As currently proposed, the preferred route will pass within approximately 1,000 feet of both the schools mentioned above. Sycamore High School and E.H. Greene Intermediate serve approximate 2,500 students. A central priority for the district is to ensure the safety and security of students, staff and visitors to our schools, and we devote significant time to the planning and review of our procedures. It continues to be my opinion that the placement of this pipeline, designed to pump natural gas at high pressure, in an area so close to a school, poses potential danger to those that utilize our buildings.

As a resident of Sycamore Community Schools myself, and a parent who has a student at Sycamore High School, I fully understand the need to provide the region with an ample supply of natural gas. However, placing a natural gas line in close proximity to any one of our schools, poses a daily safety concern for my students and for staff and visitors. As a result, I am respectfully requesting that

when the proposals for the Central Corridor Gas Pipeline are before you, as the authorizing board, you will thoughtfully consider alternatives not in close proximity to schools within the Sycamore District."
