Dear Ms. McNeal:

On June 15, 2017, Dominion Energy Ohio (“DEO”) filed a letter notifying the Ohio Power Siting Board (“OPSB”) Staff its compliance with the OPSB Staff Report of Investigation Conditions issued June 9, 2017, and as agreed to by DEO in its Supplement filed June 13, 2017. This letter serves as an update to the letter filed on June 15, 2017.

**Condition No. 1** states that prior to the commencement of construction activities in areas that require permits or authorizations by federal or state laws and regulations, the Applicant shall obtain and comply with such permits or authorizations. The Applicant shall provide copies of permits and authorizations, including all supporting documentation, to Staff within seven days of issuance or receipt by the Applicant.

In compliance with Condition No. 1, DEO submitted to Staff on June 13, 2017 and filed on June 15, 2017 a copy of the right-of-way permit from the City of Youngstown. This permit is the only one required.

**Condition No. 2** states that in the event that removal of the potential bat maternity roost tree becomes necessary, emergent survey efforts shall be coordinated with Staff and ODNR prior to removal.

There are no bat maternity roost trees that will need to be removed in the project area.

**Condition No. 3** states that Applicant shall maintain traffic along public roadways and access to adjacent land uses during construction.

DEO agrees to maintain traffic along public roadways and access to adjacent land uses during construction.

**Condition No. 4** Damage to lawns, sidewalks, and parking areas as a result of this project shall be restored to original conditions upon completion of construction, and subsequently monitored for settling, cracking and sinking during operation of the facility. Unless otherwise directed by the property owner, concrete panels (if applicable) shall be replaced in their entirety rather than cut and patched.

DEO will restore any damage to lawns, sidewalks, and parking areas as a result of this project to original conditions upon completion of construction. DEO will also monitor such areas for settling, cracking and sinking during operation of the facility.

Thus, we believe that DEO has complied with all of the OPSB Staff Report conditions. If you have any questions please call at the number listed above.
